Allan C. Carlson, Ph.D., is the President of the Howard Center for Family, Religion & Society (1997-present). He has served in a variety of positions in history and public policy including Visiting Scholar at the Labor Movement Archive in Stockholm (1977), NEH Fellow at the American Enterprise Institute (1979), Assistant to the President and Lecturer in History at Gettysburg College (1979-81), President, The Rockford Institute (1986-1997), Member, National Commission on Children (1988-91), General Secretary, World Congress of Families II (Geneva, 1999) & WCF III (Mexico City, 2004), Intercollegiate Studies Institute Honors Faculty at Oriel College, Oxford University (UK 2003). He has lectured at universities including in the United States, Puerto Rico, Russia, Sweden, and the Vatican. He is the author of eight published books, including *The Swedish Experiment in Family Politics: The Myrdals and the Interwar Population Crisis* (1990) and the forthcoming *Conjugal America: On the Public Purposes of Marriage* (forthcoming 2006).

Scott Ellis Ferrin is an Associate Professor of Educational Leadership and Foundations and Adjunct Professor of Law at Brigham Young University. He received his BA and J.D. from BYU and his M.Ed. and Ed.D. from Harvard University. He teaches and researches on education law and related constitutional issues, is a member of the Arizona and Utah bars, the law school faculty advisor to the BYU Education and Law Journal, and is a Due Process Hearing Officer on IDEA issues for the state of Utah. His current research interests include language policy in education, language acquisition issues affecting minority groups, tort principles in educational settings, special education programs; constitutional issues that affect schools; political aspects of education; and the role of in-house lobbyists in higher education. He is the founding chair of the annual Utah Education Law & Policy Institute, a conference on legal and policy issues in education, and serves on several committees in the Education Law Association, and several boards of editors and as a reviewer for peer-reviewed journals.

Andrew P. Pugno, a solo attorney practicing in Folsom, California, represents both public and private sector clients in a variety of government and public interest law matters. He serves as Chief Counsel to the Proposition 22 Legal Defense & Education Fund, a nonprofit organization founded by the late State Senator Wm. J. "Pete" Knight, the author of California's Defense of Marriage Act (Proposition 22). Mr. Pugno is also a legal advisor to ProtectMarriage.com, a coalition of conservative organizations that is presently evaluating the need and prospects of proposing an initiative amendment to the California Constitution to preserve traditional marriage.

Richard E. Redding, J.D., Ph.D., is Professor of Law at Villanova University School of Law, Research Professor of Psychology at Drexel University, and Director of the J.D./Ph.D. Program in Law and Psychology at Villanova and Drexel Universities. Previously, he was an Assistant Professor and Associate Director at the Institute of Law, Psychiatry, and Public Policy at the University of Virginia. He received his J.D. from Washington and Lee University and his Ph.D. from the University of Virginia. Professor Redding is the author of over 75 articles or book chapters in leading scientific and legal journals, and has co-authored three books. He has received awards for his work from the American Psychological Association and has been an invited speaker at many national and international conferences. He also has been a visiting

scholar at several foreign and American universities, serves on the editorial boards of several peer-reviewed journals, was the Associate Editor of the Journal of Forensic Psychology Practice, and has served as a consultant to the U.S. Justice Department. Professor Redding conducts research on the use of social science in law and public policy, sociopolitical biases in public policy research, sociopolitical diversity, judicial decision making, forensic issues in criminal law, and juvenile justice.

Walter R. Schumm, Ph.D. (Purdue University, 1979) has taught at Kansas State University for 25 years. His publications include one edited book, a published autobiography, and over 250 journal articles and book chapters. His methodological criticisms have been applied to a range of topics from research on gay parenting to family violence, military vaccination programs, prescription drug effectiveness, Gulf War illnesses, and marriage education programming. After more than 30 years of military service, he retired from the U.S. Army Reserve as a colonel in 2002. He lives on a small farm outside Manhattan, Kansas with his wife Kimberly and six of their seven children. His oldest son married in 2004 and works for the Riley County Police Department.

Roger Severino is Legal Counsel for the Becket Fund for Religious Liberty, an interfaith public-interest law firm based in Washington D.C. After graduating from Harvard Law School, Mr. Severino joined the Becket Fund in 2003 where he has worked on religious freedom cases under immigration, land-use, free speech, and international law. In addition to radio and television appearances, Mr. Severino has contributed articles on church and state for the Wall Street Journal, the New Republic Online, and Jewish World Review and has been quoted by the Chicago Tribune, World Magazine and the Weekly Standard. Before law school he received a Master's Degree in Public Policy with highest distinction from Carnegie Mellon University and a Bachelor's in Business Administration with honors from USC.

Monte N. Stewart is president of the Marriage Law Foundation. He has served in the past as United States Attorney (Nevada), Special Assistant Attorney General (Utah), Director of the Rex E. Lee Advocacy Program at Brigham Young University's law school, and Law Clerk to the Chief Justice of the United States Supreme Court. Oxford University in June 2004 awarded Mr. Stewart a post-graduate degree with distinction for his work in constitutional and family law, and his Oxford thesis, "Judicial Redefinition of Marriage," was published in September 2004 in the Canadian Journal of Family Law.

Lynn D. Wardle is a Professor of Law at the J. Reuben Clark Law School at Brigham Young University in Provo, Utah, USA. His major areas of research and writing have been family law, biomedical law, and private international law (conflicts of laws). He is the author or co-author of more than seventy law review articles and five books or treatises, and he has given expert testimony and statements to legislative committees of the U.S. Congress and of several state legislatures on many issues concerning family law. He is the Immediate Past President of the International Society of Family Law and also is a member of the American Law Institute.

Camille S. Williams, Administrative Director of the Marriage & Family Law Research Grant, BYU Law School, is an Assistant Provo City Attorney, and has practiced family law, taught family law for undergraduates, and has participated in professional seminars on family law. She

is the author of "Planned Parent-Deprivation: Not in the Best Interests of the Child," forthcoming in the *Whittier Journal of Child & Family Advocacy*, and chapters in *The Family, The Law, and the New Millennium* (1999); *The Silent Subject: Reflections on the Unborn in American Culture* (1996), and *The Bill of Rights: A Bicentennial Assessment* (1994).
