**Presenter Bios**

**Helen Alvare** teaches Family Law and other subjects at George Mason University School of Law. Previously she taught at the Columbus School of Law at The Catholic University of America. She worked in the Office of General Counsel for the National Conference of Catholic Bishops and with the Secretariat for Pro-Life Activities. She chaired a commission investigating clerical abuse in the Archdioceses of Philadelphia and is an advisor of Pope Benedict XVI's Pontifical Council for Laity. Her scholarship focuses on marriage, parenting and new reproductive techniques.

**Robert John Araujo, S.J.** holds law degrees from Georgetown, Columbia, and Oxford Universities. He practiced law with a federal regulatory agency for five years and with a major oil company for almost six years prior to entering the Society of Jesus. For twelve years he taught at Gonzaga University in Spokane and for two years at the Pontifical Gregorian University in Rome. Since 1997, he has served as an advisor to the Holy See on matters dealing with public international law. He is presently a visiting professor of law at Boston College, and has been selected as the inaugural holder of a new endowed professorship at Loyola University, Chicago, the John Courtney Murray, SJ University Professorship.

**William Binchy** is Regius Professor of Laws at Trinity College Dublin where he has served as Head of School of the School of Law. He has represented Ireland at the Hague Conference on Private International Law in the formulation of conventions on marriage and adoption. He is co-editor of *Committed Relationships and the Law* (2007) and editor of *Timor-Leste: Challenges for Justice and Human Rights in the Shadow of the Past* (2009). He is a member of the Irish Human Rights Commission and represented the Commission in the formulation of the United Nations Convention on the Human Rights of Persons with Disabilities (2007).

**Daniel Cere** is a member of the Faculty of Religious Studies at McGill University where he teaches and writes in the fields of religion, law, human rights, social ethics, gender, sexuality and marriage, and Catholic social thought. Among his recent publications are "Should Same-Sex Marriage Be Accepted" in *Crosscurrents: Contemporary Political Issues* (5<sup>th</sup> ed. 2006), *The Future of Marriage* (Institute for American Values, 2005), and *Divorcing Marriage* (co-edited with Douglas Farrow, 2005).

**The Rt. Hon. the Baroness Ruth Deech** is a member of the House of Lords of the United Kingdom. She is former Principal of St. Anne's College, Oxford (1991-2004), where she taught Family Law and other subjects, and served as Pro-Vice-Chancellor of the University of Oxford (2001-2004). She was chair of the Human Fertilisation and Embryology Authority of the UK (1994-2002), served as Independent Adjudicator for Higher Education in the UK (2004-2008), as a Governor of the BBC (2002-2006), and as a Rhodes Trustee (since 1996). She now lectures as Professor of Law at Gresham College in London where she is Professor. She is a specialist in

reproductive law, medicine and ethics, including the overlap of family law and reproductive law.

**Charles Donahue, Jr.**, is the Paul A. Freund Professor at the Harvard Law School, where he teaches property in the law school and various offerings on Roman, English, and Continental European legal history in both the law school and the college. He has written extensively on the history of marriage law in the West, particularly in the medieval period. His most recent book is *Law, Marriage, and Society in the Later Middle Ages: Arguments about Marriage in Five Courts* (New York: Cambridge University Press, 2007). He is the immediate past president of the American Society for Legal History. **Oran Doyle** lectures in constitutional law and jurisprudence at Trinity College, Dublin and is a practising barrister. He is the author of *Constitutional Equality Law* (2004) and *Constitutional Law: Text, Cases and Materials* (2008). He is the co-editor of *Committed Relationships and the Law* (2007) and *The Irish Constitution: Governance and Values* (2008), as well as the *Dublin University Law Journal*. He has published widely in the fields of constitutional law, equality law and jurisprudence.

**Martha Albertson Fineman is the** Robert W. Woodruff Professor and Director of the Feminism and Legal Theory Project at Emory University School of Law. She is one of the world's leading authorities on feminist legal theory, and is widely recognized as a leading family law scholar. She has received many awards for her writing and teaching. Among her important publications are *The Neutered Mother*, *The Autonomy Myth*, and *The Sexual Family and Other Twentieth Century Tragedies*.

**Scott FitzGibbon** is a graduate of the Harvard Law School (J.D.), where he was an Articles Officer of the Harvard Law Review, and of Oxford University (B.C.L.), where he studied legal philosophy. He is a professor at Boston College Law School, a member of the American Law Institute, and a member of the International Society of Family Law. Among his interests are jurisprudence and legal philosophy, with special attention to friendship and marriage in the Aristotelean tradition. He is the author of "Marriage and the Good of Obligation" (*American Journal of Jurisprudence*, 2002), "Marriage and the Ethics of Office" (*Notre Dame Journal of Law, Ethics, and Public Policy*, 2004), "A City Without Duty, Fault or Shame," in *RECONCEIVING THE FAMILY: CRITICAL REFLECTIONS ON THE AMERICAN LAW INSTITUTE'S PRINCIPLES OF THE LAW OF FAMILY DISSOLUTION* (Robin Fretwell Wilson, ed., Cambridge University Press, 2006), "The Seduction of Lydia Bennet: Toward a General Theory of Society, Marriage and the Family," (*Ave Maria Law Review*, 2006), and "Procreative Justice and the Recognition of Marriage," in *FAMILY LAW IN THE TWENTY-FIRST CENTURY* (2007).

**Dr. Shahar Lifshitz** is a Law professor in the Faculty of Law, Bar-Ilan University, Israel. He received a B.A. in Law and Psychology from Bar-Ilan University in 1996, and his Ph.D. in Law from the same institution in 2002. Dr. Lifshitz was Visiting Scholar and Berkowitz Fellow at New York University Law School's Global Law School in the 2005-2006 academic year, and Visiting Professor of Law and Distinguished Fellow of Jewish Law and Interdisciplinary Studies at Cardozo Law

School in 2006-2007 and spring 2009. In 2004, he won the Alon Excellent Scientist Scholarship, awarded by the Higher Council for Academic Studies in Israel, which fully sponsors young scholars in their university positions for three years. In 2005, he won the Rothschild Fellowship for post-doctorate study, as well as the Fulbright Award. Dr. Lifshitz is a researcher at the Israeli Institute for Democracy, where his specific task is to formulate a proposed law to regulate the registration of secular spouses in a civil spouses register in Israel. He participates in the meetings of the Israeli Knesset Constitution, Law, and Justice Committee, and advises the legislators on family law issues. He is a member of the Israel Ministry of Justice legislative committee for the rights of children. Dr Lifshitz's recent works include of *Civil Regulation of the Spousal Relationship* (Hebrew, forthcoming); *Cohabitation Law in Israel from the Perspective of a Civil Law Theory of the Family*, published by Haifa University Press in 2005 (Hebrew), was awarded the Bahat Prize. "Oppressive Contracts: A Jewish Law Perspective," 13 *Journal of Law and Religion* (2008); and "Distress Exploitation Contracts in the Shadow of the No Duty to Rescue," *University of North Carolina Law Review* (2008).

**Linda McClain** is Professor of Law and Paul M. Siskind Scholar of Law at Boston University School of Law. She is a nationally known scholar who writes and teaches in the areas of family law, feminist legal theory, and gender and law. She is the author of *The Place of Families: Fostering Capacity, Equality, and Responsibility* (Harvard University Press, 2006), which offers a liberal feminist theory of the relationship between family life and political life and on contested issues of family law and policy. Her forthcoming book, *Gender Equality: Dimensions of Women's Equal Citizenship* (Cambridge University Press, 2009) (co-edited with Joanna Grossman), addresses the gap between formal commitments to women's equal citizenship and persistent forms of sex inequality. Her published work includes numerous articles and book chapters. She holds a B.A. from Oberlin College; an M.A. from the University of Chicago Divinity School; a J.D. from Georgetown University Law Center; and an LL.M. from New York University School of Law. She is a former fellow of the Harvard University Safra Foundation Center for Ethics and the former Rivkin Radler Distinguished Professor of Law at Hofstra Law School. She is beginning a new book on civil society, *Free and Equal Association*.

**Susan Shell** is Professor and Chair of the Department of Political Science at Boston College. Her publications include books and essays on modern political philosophy and its bearing on contemporary jurisprudence and issues of marriage and the family. She is the author of "The Liberal Critique of Gay Marriage," *THE PUBLIC INTEREST*, 2004. Her most recent book, *KANT AND THE LIMITS OF AUTONOMY*, is forthcoming from Harvard University Press.

**Richard Stith** is a Professor of Law at Valparaiso University School of Law where he has taught since 1973. He has also served as Director, Biomedical Ethics, at St. Louis University School of Law, and as Visiting Professor (Philosophy) at Poona University, India (Fulbright, 1980-1981), Universidad de Valparaíso, Chile (Law) (Fulbright, 1988), Zhongshan University, China (Law) (Fulbright, 1992), UKMA, Ukraine (Political Science) (Fulbright, 1996), and Universidad Panamericana, Mexico (Law) (Fulbright, 2000-2001). He is a graduate of Harvard College, Yale Law School, and has graduate degrees from University of California, Berkeley (Political Theory) and Yale University (Religious Ethics). **Lynn D. Wardle** is the Bruce C. Hafen Professor of Law at the J. Reuben Clark Law School at Brigham Young University where he began teaching in 1978. His primary fields of teaching and writing are family law, comparative family law, conflict of laws, and U.S. constitutional history. Professor Wardle was President (2000-02) and Secretary-General (1994-2000) of the International Society of Family Law (ISFL), and serves on the ISFL Executive Council. He also is a member of the American Law Institute. His recent publications include *What's the Harm? Does Legalizing Same-Sex Marriage Really Harm Individuals, Families or Society* (Lynn D. Wardle, ed., 2008), and *Marriage and Quasi-Marital Relationships in Central and Eastern Europe* (Lynn D. Wardle & A. Scott Loveless, eds. 2008).
