Bios

Elizabeth Barker Brandt is the James E Rogers distinguished Professor of Law at the University of Idaho. She teaches in the areas of Community Property, Family Law, Wills and Trusts and Real Estate Transactions. Brandt is a member of the editorial Board of the ABA Family Law Quarterly. She has published articles dealing with family court organization and reform, community property, civil procedure and the first amendment. Brandt served as the primary author and editor of Protecting Children of High Conflict Divorce: An Idaho Benchbook, Idaho Family Law Forms, Idaho Judge's Deskbook and the Idaho Child Protection Manual and Annotated Forms. In 1998 she received the Family Law Section of the Idaho State Bar's Award of Distinction and currently serves as the Secretary of the Idaho Family Law Council.

David C. Dollahite, PhD is Professor of Family Life and an Eliza R. Snow Fellow at Brigham Young University. He has conducted research with Jewish, Christian, and Muslim families in New England and Northern California. He has served a President of the Utah Council on Family Relations and is a member of the Utah Governor's Commission on Marriage. David and his wife, Mary, are the lucky parents of seven terrific kids.

William C. Duncan is a Fellow of the Sutherland Institute in Salt Lake City, Utah. He has previously served as the executive director of the Marriage and Family Law Grant at the J. Reuben Clark Law School, Brigham Young University where he served as a Visiting Professor. Mr. Duncan previously served as the acting director of the Marriage Law Project based at the Columbus School of Law, The Catholic University of America. He graduated from J. Reuben Clark Law School in 1998. He has also served as counsel to the Secretary of Education's Commission on Opportunity in Athletics. Mr. Duncan has published numerous articles in legal journals and other publications on issues related to family law and policy and the constitution.

Professor Deborah Forman received her undergraduate degree with honors from Brown University, where she was elected to Phi Beta Kappa. She received her J.D. from Stanford Law School, where she served as an editor on the Stanford Law Review. After graduation, she clerked for the Honorable Harry Pregerson on the 9th Circuit Court of Appeals. Professor Forman has been on the faculty at Whittier Law School since 1990, where she teaches Family Law and related courses. She has also served as Director of Whittier's Center for Children's Rights since 1999. She is the author of Every Parent's Guide to the Law (Harcourt 1998) and has written and spoken throughout the nation on a variety of family law topics.

Alan J. Hawkins is a professor of Family Life at Brigham University in Provo, Utah. He earned a Masters of Organizational Behavior from BYU in 1984, and Ph.D. in Human Development and Family Studies at The Pennsylvania State University in 1990. He has been teaching and conducting research and outreach at Brigham Young University since then. Professor Hawkins' early scholarship and outreach have focused on fathers' involvement with their children and the effects of that involvement on men's development, as well as the division of domestic labor in dual-earner households. Recently, his work has focused on exploring ways to strengthen marriage through marriage education and public policy. During the past year he was a visiting scholar with the Office of Planning, Research, and Evaluation, Administration for Children and Families, U.S. Department of Healthy and Human Services, working on ACF's healthy marriage policy initiatives.

Lynn Hogue is a Professor in the College of Law at Georgia State University. He joined the faculty in 1982. He currently teaches courses on constitutional law, conflict of laws and American constitutional history. He is an active member of the bar in Georgia, Arkansas and North Carolina. He has argued cases before the Georgia Supreme Court, the Eleventh Circuit Court of Appeals and lower federal and state courts. Professor Hogue received an A.B. degree (1966) from William Jewell College; M.A. (1968) and Ph.D. (1972) degrees from the University of Tennessee; and a J.D. degree (1974) from Duke University Law School. He is the co-author of *National Security and Military Law in a Nutshell*, (Thomson/ West 2003), a treatise on conflict of laws in Georgia, and numerous articles on constitutional law and conflict of laws including an article *State Common-Law Choice of Law Doctrine and Same-Sex "Marriage": How Will States Enforce the Public Policy Exception?* published in 32 *Creighton L. Rev.* 29 (1998).

Laurence C. Nolan is a professor of law at the Howard University School of Law in Washington, D.C. She teaches in the areas of family law and the law of wills, trusts & estates. Her scholarship has focused mainly in the area of family law. Her most recent article, published in vol. 82 of the *University of Oregon Law Review* (2003), critiques society's response to the needs of posthumously conceived children. She is also the co-author with Professor Lynn D. Wardle of a family law casebook, *Fundamental Principles of Family Law*, and of the *International Encyclopaedia of Laws, Family and Succession Law, United States of America*, (Vol. 2, Supp. 5 & 6) (Gen. Ed. R. Blanpain, Ed. W. Pintens) (Kluwer Law Int'l, The Hague, 1998).

Patrick Parkinson is a professor at the Faculty of Law, University of Sydney, Australia and a specialist in family law, child protection and the law of equity and trusts. He has written and edited a number of books on these areas. He is, a member of the Family Law Council, and the editor of the *Australian Journal of Family Law*. He is co-author of *Australian Family Law in Context*, and editor of *The Principles of Equity*, as well as

being the author of a book on the origins and development of the legal system in Australia. He has been the Principal National Examiner for specialist accreditation in family law since 1999. He is a member of the Executive Council of the International Society of Family Law.

Professor Parkinson is also well-known for his work concerning child protection. He has been a member of the NSW Child Protection Council, and was Chairperson of a major review of the state law concerning child protection which led to the enactment of the Children and Young Persons (Care and Protection) Act 1998 in NSW. He has written a book called *Child Sexual Abuse and the Churches* (2nd ed, 2003, distributed by Haworth Press in the USA) and has been a consultant to the Catholic Church in Australia on its procedures for dealing with abuse in church communities.

E. Vance Randall, Ph.D. is a professor and chair of the Department of Educational Leadership and Foundations at Brigham Young University, Provo, UT. His scholarly interests are in the field of social and political philosophy of education. Specific research topics include private education and privatization both domestically and internationally, governance, equity, normative policy analysis, and culture and religion in education. He is the author of three books: *Private Schools and Public Power: A Case for Pluralism* (Teachers College Press, 1994), *Advocacy or Accuracy: The Politics of Research in Education*, co-edited with Bruce Cooper (Sage, 1999), and *Better Policies, Better Schools*, co-authored with Bruce Cooper and Lance Fusarelli (Allyn & Bacon, 2004).

Vincent J. Samar is an LL.M. student at Harvard Law School. He is also an Adjunct Professor of Law at Illinois Institute of Technology, Chicago-Kent College of Law, and an Adjunct Professor of Philosophy at both Loyola University Chicago and Oakton Community College. He is the author of *Justifying Judgment: Practicing Law and Philosophy* (University Press of Kansas, 1998), *The Right to Privacy: Gays, Lesbians and the Constitution* (Temple University Press, 1991), and editor of *New York Times, 20th Century in Review: Gay Rights Movement* (2001), along with also having published numerous articles and review articles in law, philosophy, same-sex marriage, and gay rights as human rights.

Lynn D. Wardle graduated from Brigham Young University and Duke University School of Law. He clerked for U.S. District Judge John J. Sirica (DC, 1974-75, during Watergate), then practiced law in Phoenix, Arizona, until joining the faculty of the at Brigham Young University Law School in 1978. He has taught Family Law other subjects since then. He has taught as a Visitor at Howard University School of Law, at the University of Queensland (T.C. Beirne) Law School (Brisbane, Australia), Sophia

University Faculty of Law (Tokyo, Japan), and at the University of Aberdeen (Scotland) as a Visiting Research Fellow. He is co-author (with Nolan) of *Fundamental Principles of Family Law* (Wm. S. Hein & Co. 2002); lead editor of *Contemporary Family Law* (4 vols) (1988), author, co-author, or editor of seven other books, and 85 other law review articles, chapters, and essays, most about family law. Recent publications include *Is Marriage Obsolete?*, 10 *Mich. J. Gender & L.* 189 (2003); *Marriage, Relationships, Same-Sex Unions, and the Right of Intimate Associations*, in *Marriage and Same-Sex Unions: A Debate 190-202* (Lynn D. Wardle, Mark Strasser, William C. Duncan, & David Orgon Coolidge, eds. Praeger, 2003); *Parental Infidelity and the "No-Harm" Rule in Custody Litigation*, 52 *Cath. U. L. Rev.* 81-132 (2002); *Genetics and Artificial Procreation in the U.S.A.*, (with Schneider) in *Biomedicine, The Family and Human Rights* 55 (2002); *Deconstructing Family: A Critique of the American Law Institute's "Domestic Partners" Proposal*, 2001 *B.Y.U. L. Rev.* 1189; *"Multiply and Replenish": Considering Same-Sex Marriage in Light of State Interests in Marital Procreation*, 24 *Harv. J. L. & Pub. Pol'y* 771 (2001); and *Divorce Reform at the Turn of the Millenium: Certainties and Possibilities*, 33 *Fam. L. Q.* 783 (1999). He is the Immediate Past-President of the International Society of Family Law, and is a member of the American Law Institute. He testified before Committees of the U.S. Congress and state legislatures about various family policy issues including the Defense of Marriage Act and state DOMAs. Married since 1973, Lynn and Marian Wardle have two children and two grandchildren.

Nicholas H. Wolfinger is Assistant Professor in the Department of Family and Consumer Studies and Adjunct Assistant Professor of Sociology at the University of Utah. His book on the intergenerational transmission of divorce will be published by Cambridge University Press in 2005. He is also the author or co-author of articles about divorce published in *Demography*, *Social Forces*, *Journal of Health and Social Behavior*, *Social Science Research*, and other journals.

Camille S. Williams is an Assistant Provo City Attorney, and teaches family law to undergraduates at Brigham Young University. She has a small solo practice in mostly family law, and her research interests and publications focus on women's issues, and the family and the law.
